VENDORS CONTRACT

This annual event has been organized by the Caledon Agricultural Society since 1989 and will be held this year on Tuesday July 1, 2025. It has been drawing crowds of 2000 and up annually. Event hours are 9am – 4pm. Caledon Fairgrounds are located at 18279 Hurontario Street (Hwy 10) just south of Charleston Sdrd on the EHS.

Vendors must provide **Proof of Insurance**. The Caledon Agricultural Society and the address must be named on the insurance.

Spaces are 10' x 10' square, outdoor only. Multiple spaces are permitted. Participants must provide their own tables, chairs, displays etc.

A volunteer will be on the grounds for setup between 5pm and 7pm on June 30, and starting at 7am on July 1. We will have overnight security on June 30th. Please do not leave valuable goods unattended.

All spaces must be pre-registered by June 1st, and paid in full before set-up is permitted, no refunds. Once assigned, space locations will not be changed.
